2017-2018 PARCEL TAX Senior Citizen Exemption Form Instructions

This parcel tax exemption is for one or more property owners who are over 65 years of age or older on June 30, 2017.

1. **This parcel tax exemption is for your principal place of residence only,** and applies to one parcel only.
2. The Measure A parcel tax requires an application or a returned signed letter of verification by June 15 of each year to claim an exemption for the term of the tax year that begins the following July 1st.
3. The parcel tax applies to parcels with land value. If your parcel is taxed for improvement value only (as in some mobile home parks), the parcel tax will not be assessed on your parcel, and you do not need to fill out this application.
4. To find your Parcel Number, look for the 8 digit number (XXX-XX-XXX) on your property tax bill, or call the County Assessor at 408-299-5500 for Santa Clara County. The Parcel Number for Santa Cruz County is listed as XXXXXXXX and the Santa Cruz County Assessor's telephone number is: 831-454-2510.
