<b>Budget Update</b>	Mr. Fagot noted that expenditures have increased beyond received increases in revenue at Second Interim. Mr. Fagot noted that the Town of Los Gatos anticipates that 35% of the population will be over 65 and under Proposition 13, possibly further reducing Parcel Tax revenues. Ms. Ramon Herrera noted additional property tax revenue comes from other sources. Ms. Pottage noted we are utilizing an assumption regarding Property Tax revenues rather than an actual projection - at this point. While Ms. Pottage is anticipating over 4.5 %, she will not adjust the budget #'s yet.
<b>Proposed Parcel Tax Budget</b>	We anticipate using Parcel Tax revenues for teacher salaries per the language of the Parcel Tax, 2019-20. Mr. Miller noted the importance of letting the community know Parcel Tax revenues are being used to keep class sizes down.



<b>Committee Member Comments</b>	Mr. Miller asked that staff share updates regarding terms of PTOC members.
